

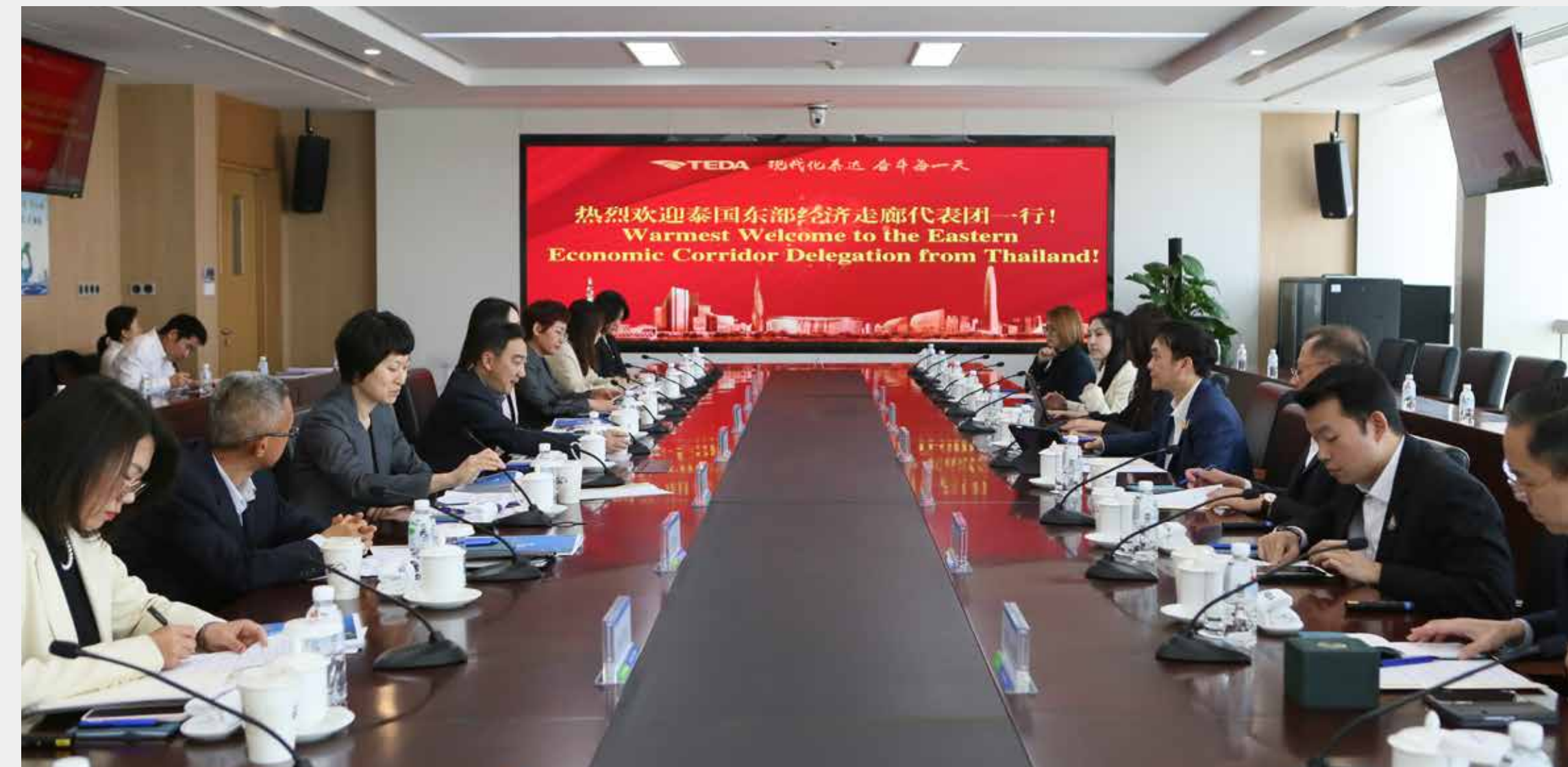
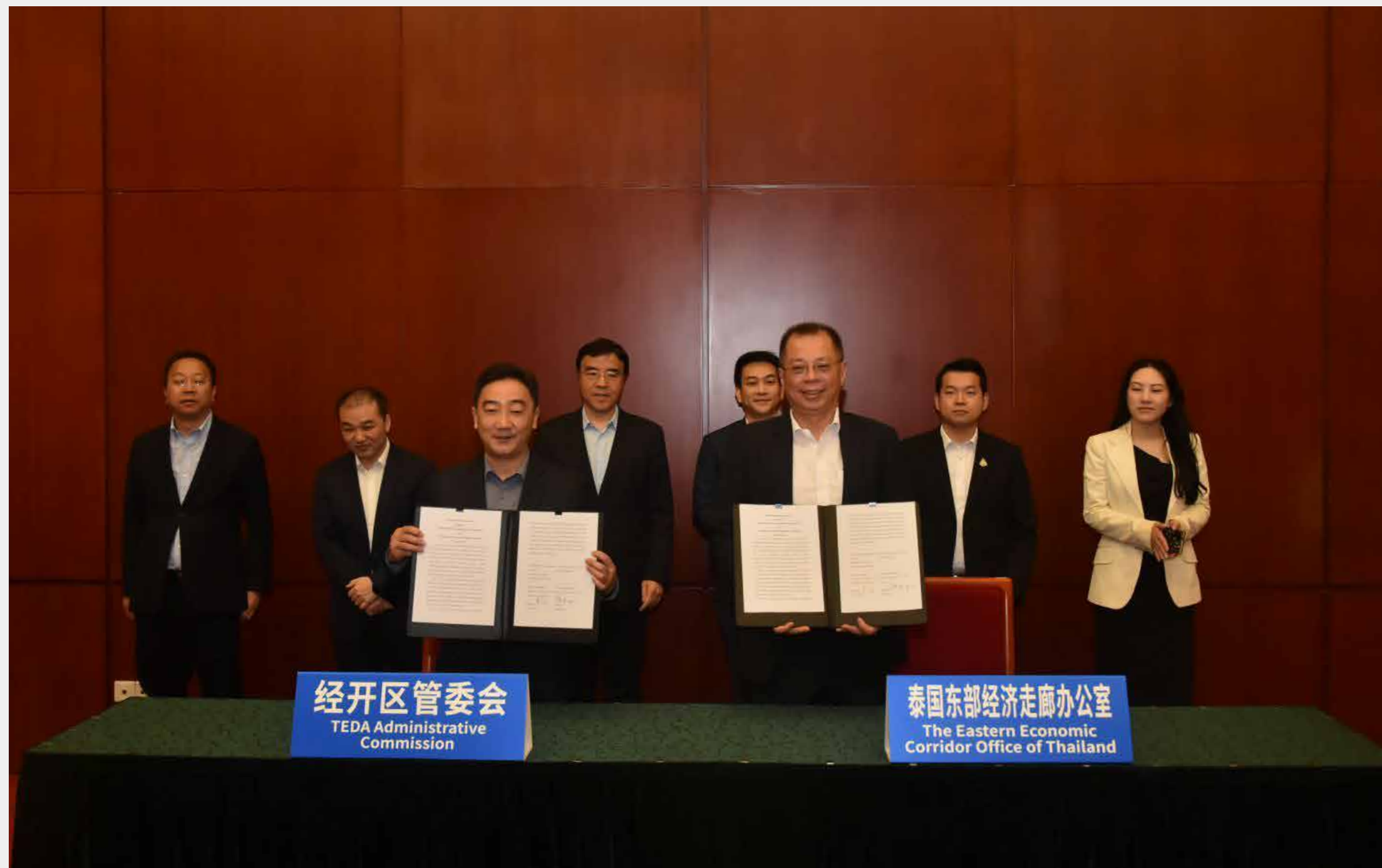


## OUR SUCCESS CASES
